Bear Valley Electric Service, Inc. ("BVES") hereby transmits for filing the following:

SUBJECT: Bear Valley Electric Service, Inc.'s Residential Customer Disconnection Rate Cap for 2025

PURPOSE

BVES is filing this Advice Letter in compliance with Decision No. ("D.") 22-08-037.

BACKGROUND

On August 25, 2022, the California Public Utilities Commission ("Commission" or "CPUC") issued D.22-08-037, in Rulemaking No. 18-07-005, Phase 1-A Decision Establishing Residential Disconnection Protections for Small and Multijurisdictional Utilities ("SMJUS"). D.22-08-037 ordered Southwest Gas Company, Liberty Utilities LLC, Bear Valley Electric Service, PacifiCorp, Alpine Natural Gas Operating Company, and West Coast Gas Company, Inc. to, among other things, implement residential customer protections and reporting requirements to reduce disconnections and ease reconnections of residential service.

COMPLIANCE

Pursuant to Ordering Paragraph No. ("OP") 2 of D.22-08-037, BVES submits this Tier 1 advice letter to provide metrics and calculations determining its disconnections rate cap for 2024. OP 2 states,

Southwest Gas Company, Liberty Utilities LLC, Bear Valley Electric Service, a division of Golden State Water Company, PacifiCorp, Alpine Natural Gas Operating Company, and West Coast Gas Company, Inc. shall each file a Tier 1 Advice Letter with the following information within 30 days of the effective date of this decision and by February 1st each calendar year thereafter: (i) the total number of its California residential customers during the previous calendar year, (ii) the number of California residential customers it may disconnect during the current calendar year, calculated as the product of its disconnections rate cap and the total number of its California residential customers during the previous calendar year, and (iii) the number of California residential customers it disconnected during the previous year, compared with the number of California residential customers it was permitted to disconnect during the previous year.

BVES provides in Table 1 below its 2024 total number of residential customers, the 2025 number of customers that BVES may disconnect, and the 2024 number of customers that BVES did disconnect compared to the number of customers permitted to disconnect.

A protest must state the facts constituting the grounds for the protest, the effect that approval of the advice letter might have on the protestant, and the reasons the protestant believes the advice letter, or a part of it, is not justified. If the protest requests an evidentiary hearing, the protest must state the facts the protestant would present at an evidentiary hearing to support its request for whole or partial denial of the advice letter. There is no restriction on who may file a protest.

The utility must respond to a protest within five days.
