Bear Valley Electric Service, Inc. ("BVES") hereby transmits for filing the following:

SUBJECT: Establish the Income Graduated Fixed Charge Memorandum Account

PURPOSE

Pursuant to Decision ("D.") 24-05-028, Ordering Paragraphs ("OP") 1 and 9, BVES is filing this advice letter to create a new Income-Graduated Fixed Charge ("IGFC") Memorandum Account ("IGFCMA").

1. Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, Bear Valley Electric Service, Inc., Liberty Utilities, and PacifiCorp d/b/a Pacific Power shall each file a Tier 1 advice letter within 30 days of the issuance date of this decision to create (a) a new Income-Graduated Fixed Charge Memorandum Account and (b) a new Income-Graduated Fixed Charge Balancing Account.¹

9. Bear Valley Electric Service, Inc., Liberty Utilities, and PacifiCorp d/b/a Pacific Power shall each file a Tier 1 advice letter within 30 days of the issuance date of this decision to create a new income-graduated fixed charges memorandum account to track all implementation costs and incremental administration costs of income-graduated fixed charges.²

The IGFCMA will be used to track and record all implementation costs and incremental administration costs associated with the income-graduated fixed charges.³ While OP 1 includes the implementation of an IGFC Balancing Account, BVES is not requesting an IGFC Balancing Account at this time because, pursuant to OP 11 of D.24-05-028, BVES will "record any over- or under-collection of revenues by income-graduated fixed charges as a separate line-item in its existing Base Revenue Requirement Balancing Account." BVES is requesting a modification to its Base Revenue Requirement Balancing Account Preliminary Statement to incorporate the requirement in OP 11.

BACKGROUND

On June 30, 2022, Assembly Bill ("AB") 205 was signed into law. On July 14, 2022, the Commission issued an Order Instituting Rulemaking 22-07-005 to establish demand flexibility policies and modify electric rates to advance the following objectives:

(a) enhance the reliability of California's electric system; (b) make electric bills more affordable and equitable; (c) reduce the curtailment of renewable energy and greenhouse gas emissions associated with meeting the state's future system load; (d) enable widespread electrification of buildings and transportation to meet the state's climate goals; (e) reduce long term system costs through more efficient pricing of electricity; and (f) enable participation in demand flexibility by both bundled and unbundled customers.⁴

IGFC MEMORANDUM ACCOUNT

D.24-05-028 states that each utility is to establish a memorandum account to track all incremental implementation and administrative costs of income-graduated fixed charges and recover these costs through a future request. Costs to be included in the memorandum accounts may include, but are not limited to, the costs of upgrading billing systems, communications and outreach to customers to educate and inform customers about new IGFCs, and any costs of complying with any Commission mandated implementation and/or ongoing IGFC requirements.⁵ The disposition of any balance in this account will be addressed in a future Application.

TIER DESIGNATION

This advice letter is submitted with a Tier 1 designation, pursuant to D.24-05-028.

EFFECTIVE DATE

BVES respectfully requests this advice letter become effective June 14, 2024

NOTICE AND PROTESTS

A protest is a document objecting to the granting in whole or in part of the authority sought in this advice letter. A response is a document that does not object to the authority sought, but nevertheless presents information that the party tendering the response believes would be useful to the Commission in acting on the request.

A protest must be mailed within 20 days of the date the Commission accepts the advice letter for submission. The Calendar is available on the Commission's website at www.cpuc.ca.gov.

A protest must state the facts constituting the grounds for the protest, the effect that approval of the advice letter might have on the protestant, and the reasons the protestant believes the advice letter, or a part of it, is not justified. If the protest requests

	a.	Entries shall be made to the IGFCMA at the end of each month to record the costs to the account or appropriate subaccounts.	
	b.	Interest shall to the IGFCMA on a monthly basis by applying a rate equal to one- twelfth of the 3-month Commercial Paper Rate, as reported in the Federal Reserve Statistical Release, to the average of the beginning-of-month and the end-of-month balances.	
5.	<u>EFFECTIVE DATE</u> The IGFCMA shall have the effective date of June 14, 2024.

V. BASE REVENUE REQUIREMENT BALANCING ACCOUNT (continued)

5. <u>ADJUSTMENTS TO THE REVENUE REQUIREMENT</u>

The annual revenue requirement levels in Section 4 may be adjusted, if needed, by an update as a result of changes to BVES' allocation of GSWC's (i) General Office cost, (ii) common plant cost or (iii) employee pension and benefit costs, each as approved by the Commission in GSWC water operations application filed before the Commission, or by some other appropriate proceeding that establishes a new BVES base rate revenue requirement or an addition to the BVES base rate revenue requirement shown in Section 4. The annual revenue requirement levels in Section 4 also may be adjusted, if needed, by an update as a result of the disposition of balances in the Pension Balancing Account, or advice letter filings regarding the completion and placement into commercial operation of the (i) Pineknot Substation Project or (ii) the Grid Automation Project.

6. TRANSFERS AND ADJUSTMENTS TO THE BRRBA BALANCE

From time to time the Commission may find that an amortization of a base rate memorandum or balancing account it authorized has run for the required number of months but that there remains an unamortized over- or under- collected balance at the end of the amortization period. The unamortized balances for such accounts may be transferred to the balance in the BRRBA if the costs covered by the account are base rate related costs. Additionally, pursuant to Ordering Paragraph #11 of D.24-05-028, BVES will record any over- or under-collection of revenues by income-graduated fixed charges as a separate line-item.

7. ACCOUNTING PROCEDURES:

GSWC shall maintain the BRRBA by making entries at the end of each month as follow:

- a. Recorded monthly base rate revenues.
- b. Apportioned monthly allocation of the authorized annual base rate revenue requirement as described in Section 4.
- c. Total net BRRBA balance: 7.a. minus 7.b.
- d. GSWC shall apply interest to the average net balance in the BRRBA account at a rate equal to onetwelfth the interest rate on three-month Commercial Paper for the previous month as reported in the Federal Reserve Statistical Release, H.15, or its successor publication. Accumulated interest will be included in the amount on which interest is charged, but will be identified as a separate component of the BRRBA account.

8. <u>EFFECTIVE DATE</u>

As reflected in the Settlement Agreement approved by the Commission in D. 19-08-027, the revenue requirements for 2018, 2019, 2020, 2021 and 2022 are effective as of January 1, 2018, January 1 2019, January 1, 2020, January 1, 2021, and January 1, 2022, respectively.

9. ACCOUNT DISPOSITION

The disposition of the balance in the BRRBA at the close of each year, plus any transfers or adjustments authorized to be made to the BRRBA, will be addressed by GSWC in a Tier 2 Advice Letter filing if the amount of the under- or over-collection is equal to or greater than 5% of the revenue requirement established for the previous twelve months. Should such a trigger be met, GSWC may file the required advice letter with the necessary amortization charge expected to amortize the balance over the next twelve months.
