Bear Valley Electric Service, Inc. ("BVES") hereby transmits for filing the following:

SUBJECT: <u>Bear Valley Electric Service, Inc. Information-only Advice Letter of Electric Rule 20 in</u> Compliance with Ordering Paragraph 5 of Decision No. 23-06-008.

PURPOSE

The purpose of this Advice Letter is to notify the California Public Utilities Commission ("Commission") that BVES does not have a Rule 20 program and has not collected funding, thus, there are no reallocation of funds. This Advice Letter is being filed in compliance with Ordering Paragraphs No. 5 in Decision No. ("D.") 23-06-008. Ordering Paragraphs No. 5 states,

Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, Bear Valley Electric Service Company, Liberty Utilities, and PacifiCorp shall each file a Tier 2 advice letter within 18 months of the effective date of this decision to propose reallocations of Electric Rule 20A work credits in accordance with Ordering Paragraph 4 above. Each utility may only file one Tier 2 advice letter that contains a consolidated list of proposed reallocations of work credits. If a utility does not intend to make any reallocations of Electric Rule 20A work credits, the utility may file a Tier 1 advice letter to notify the Commission that it will not make any reallocations of work credits during the remainder of the Electric Rule 20A program. Each Tier 2 advice letter must contain the following information:

(a) A detailed narrative explanation of the utility's overall reallocation prioritization process, including an explanation of how the utility's prioritization methodology for selecting projects complies with this decision;

(b) An accounting of all inactive communities and final work credit balances to be reallocated, with totals; and

(c) An accounting of all projects that will receive a reallocation of Rule 20A work credits in the form of a template to be provided by the

Commission's Energy Division, including: (i) the information in Attachment A; (ii) how many work credits will be reallocated to the eligible project; and (iii) a short explanation of why the project was selected for reallocation.

BACKGROUND

The Commission issued Order Instituting Rulemaking No. ("Rulemaking") 17-05-010 to consider revisions to Electric Rule 20 and related matters. The Rulemaking described the long history of the program, dating back to 1967. Electric Rule 20 defines policies and procedures for electric utilities to convert overhead power lines and other equipment to underground facilities at the request of a city, unincorporated county, or private applicant.

On June 8, 2023, the Commission issued D.23-06-008, approving a revised Electric Rule 20, which closes Rulemaking 17-05-010 and orders BVES to file this Tier 1 Advice Letter, if applicable.

TIER DESIGNATION

This advice letter is submitted with a Tier 1 designation.

EFFECTIVE DATE

BVES respectfully requests this advice letter become effective December 9, 2024.

NOTICE AND PROTESTS

A protest is a document objecting to the granting in whole or in part of the authority sought in this advice letter. A response is a document that does not object to the authority sought, but nevertheless presents information that the party tendering the response believes would be useful to the Commission in acting on the request.

A protest must be mailed within 20 days of the date the Commission accepts the advice letter for submission. The Calendar is available on the Commission's website at www.cpuc.ca.gov.

A protest must state the facts constituting the grounds for the protest, the effect that approval of the advice letter might have on the protestant, and the reasons the protestant believes the advice letter, or a part of it, is not justified. If the protest requests an evidentiary hearing, the protest must state the facts the protestant would present at an evidentiary hearing to support its request for whole or partial denial of the advice letter.

The utility must respond to a protest within five days.
